Notes

Areas requiring structural investigation were visited and were the primary reason for the field visit. The north Emmons selective demolition had begun but further demolition is required to understand the nature of the cracking and wall separation at the areas of interest. Mike Ingle was informed of the additional demolition required (see pictures to follow). No selective demolition has occurred to date at the south Emmons location or Axtel Plaza location. Structural investigation is on hold until the areas of interest are exposed. Further demolition may be required once the areas of interest are exposed.

Structural action items

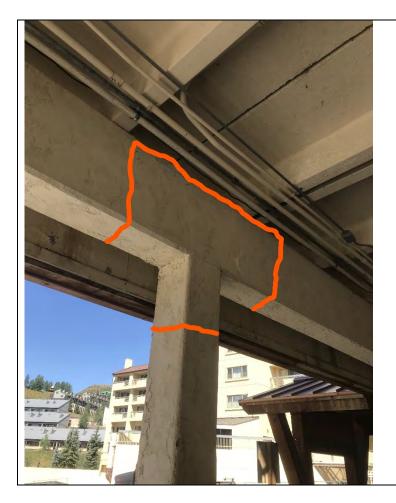
1. Observe three areas requiring structural investigation once selective demolition is complete. Determine future course of action once damage is assessed.
